## WATERLOO PARK DISTRICT LAKEVIEW DOG PARK RULES (as of April 2024)

## THE DOG PARK IS OPEN FROM DAWN TO DUSK ONLY! THE DOG PARK WILL BE CLOSED DURING ROUTINE MAINTENANCE.

- 1. NO FOOD IS PERMITTED IN THE DOG PARK AREA.
- 2. NO TOBACCO PRODUCTS OR SMOKING IN THE DOG PARK AREA (ANY DISCARDED PRODUCTS/ITEMS MAY HARM PETS).
- 3. DOG OWNERS MUST CLEAN UP AFTER THEIR PETS AND THEMSELVES.
- 4. NO AGGRESSIVE DOGS ALLOWED; SEE CITY OF WATERLOO ORDINANCE 3-1-16 (C).
- 5. DOGS MUST BE HEALTHY, LICENSED, AND HAVE CURRENT VACCINATIONS.
- 6. PUPPIES UNDER (4) FOUR MONTHS OF AGE ARE PROHIBITED.
- 7. DOG OWNERS MUST HAVE INDIVIDUAL LEASHES WITH THEM AT ALL TIMES.
- 8. DOGS IN SEASON ARE NOT ALLOWED.
- 9. CHILDREN UNDER 10 YEARS OF AGE MUST BE ACCOMPANIED BY AN ADULT. YOUNG CHILDREN MUST BE CLOSELY SUPERVISED.
- 10. THE WATERLOO PARK DISTRICT RECOMMENDS THAT ANIMALS BE SPAYED/NEUTERED PRIOR TO USING THIS FACILITY.
- 11. DOG OWNERS ARE LIMITED TO (3) THREE DOGS USING THE FACILITY PER VISIT.
- 12. DOG OWNERS ARE LEGALLY RESPONSIBLE FOR THEIR DOG'S ACTIONS/BEHAVIOR.
- 13. DOGS MUST BE LEASHED WHEN ENTERING THE DOG PARK AREA AND BEFORE LEAVING THE DOG PARK AREA.
- 14. DOGS LEFT UNATTENDED MAY BE IMPOUNDED; SEE CITY OF WATERLOO ORDINANCE 3-1-8 (B).
